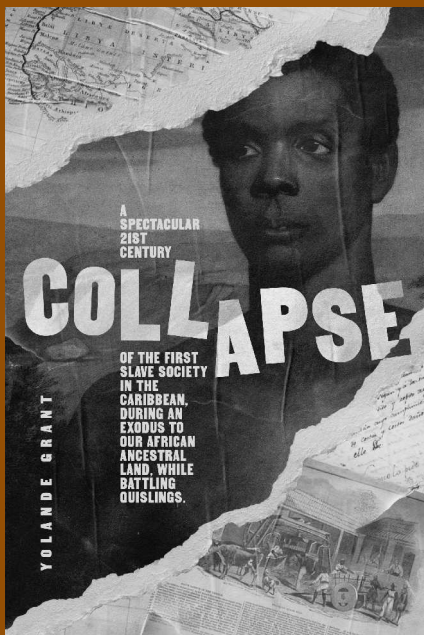

A Supreme Court Judge's Decision

After eight (8) long years of playing fast and loose with the lives and safety of the Barbados population, it all came to a screeching halt when judgements for high civil crimes and misdemeanors perpetrated on electoral voter(s) were handed down by the Barbados Supreme Court against the illicitly holding on at any cost government. Unheard of historic wins for local people since the inception of the Bar Association (1940) and Judiciary. Unfortunately, the unfolding news was repressed in the most vicious of coverups by local media in November of 2025 when the first decision was handed down. On May 24, 2018 when government was elected their appointed attorneys filed and successfully arbitrated a petition to the Supreme Court allowing Commonwealth citizens (from over 50 countries) to vote in Barbados, setting a precedent with much fanfare, and the Judge's ruling was accepted. Fast forward to January 18, 2022 when a case was filed in the same Supreme Court for the tort injury suffered by thousands of voters denied their constitutional right and that case was dragged around with delays by 18 government lawyers for four years to obstruct outcomes, and no media house or social media platform carried the news of the judge's verdict even though it will impact them all as part of the collective, at some time, While the government openly repelled the conclusion.

With two recorded precedents for voting rights, the first ironically adjudicated by government attorneys initially for commonwealth citizens only, and the other by attorney Philip Caitlyn, for local voters, will govern into the future how elections proceed, as all filings will have their genesis in both. The cabinet once again opened the door for another challenge to certify the local electorate's right to inclusion on the voter's roll, reported by many as again violated in 2026 with thousands unable to participate, in a continuation of the original filing.

An investigative deep dive into how politicians use their shareholder control in entities to achieve muzzling the press is now warranted when decisions from the taxpayer funded Supreme Court do not go in their favor. This week another election saw voters once again unrepresented and voting rights trampled with impunity, but the null and void "win" was galavanted around with festivity, and plenty regional advertising. It has become noticeable that the local press is treating these realities and associated dangers like they do not exist, and do no serious reporting, outside of the sensational and scripted versions allowed by government.

Apparently, no amount of wealth, land theft, estate harvesting, money mining of treasuries by the billions of dollars, and everything else they and their political Carigone servants mooch off Black people generationally is enough to satisfy them: and obviously plan to continue on that freeloading trajectory indefinitely as allowed by those who sit quietly and do nothing about this criminal invasion, that crossed racial lines decades ago in some instances and definitely affecting everyone in real time. 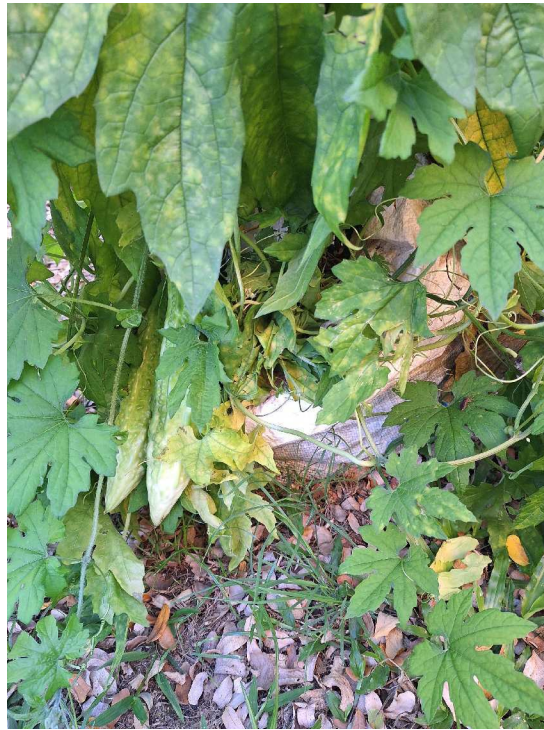

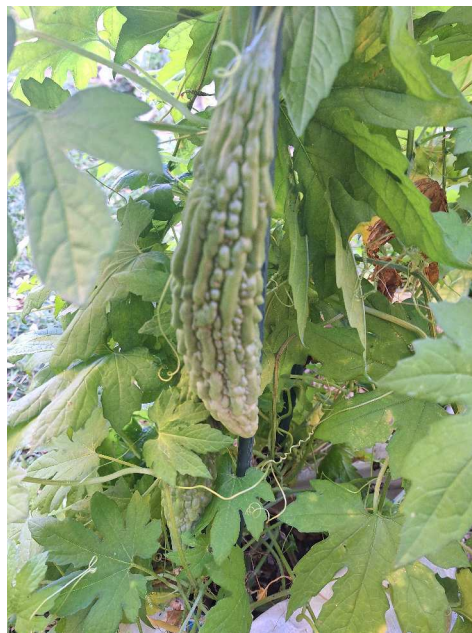
