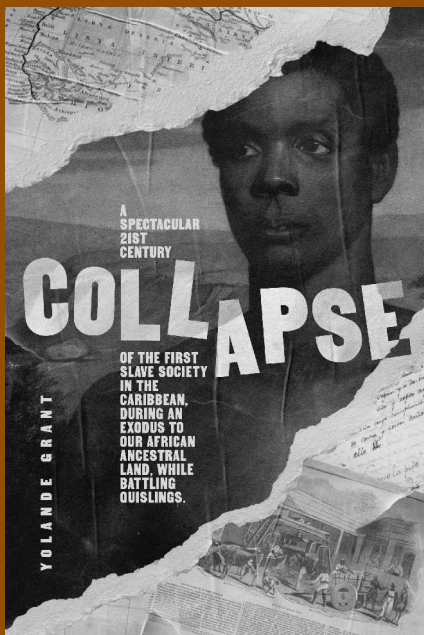

The Zong Massacre

In 1781, the legal proceedings around the Zong marked the opening round of the end of the British slave trade. In August 1781. The British ship Zong departed from the port of Accra, in Ghana on the west coast of Africa, and set out for Jamaica. In her hold were 442 people, but they were not passengers - they were cargo.

The Zong was a slave ship.



Her Captain was Luke Colligwood, who had previously served as surgeon on several ships. This was his first time in command. But Collingwood was sick and incapacitated most of the time (and would die a short time after the voyage), and the First Mate, James Kelsall, had been relieved of duty after a dispute, so the ship seems to have been mostly run by a passenger named Robert Stubbs, who had been a former slave-ship captain. It remains unclear who was in charge.

Now, someone in command made a business decision. Under British trade laws, the ship's insurer would be liable to pay compensation for any cargo that was lost to accident during the voyage, and the crew decided to jettison that part of the load that was already weak or sick, which being necessary for the ship, would make them liable for insurance compensation. Over the next few days, they threw over 120 of the chained Africans overboard to drown. (During this time another 10 Africans deliberately jumped overboard to commit suicide.)

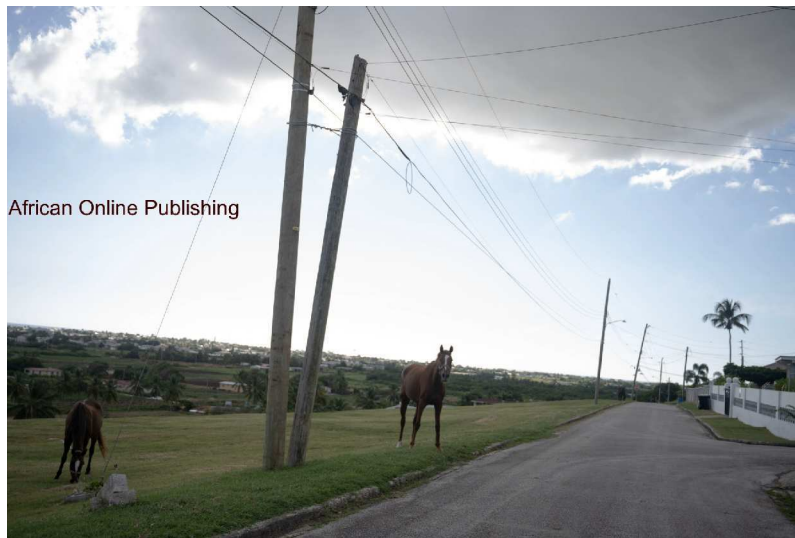

Then the ship finally arrived in Jamaica in December, there were only 208 slaves still alive, and the Zong's owners, a consortium of merchants headed by James Gregson (a former Mayor of Liverpool), filed a claim with the insurer, Thomas Gilbert of Liverpool, for the lost cargo, seeking 30 pounds for each slave.

But Gilbert refused to pay off the claim, arguing that it was Collingwoods own fault that the slaves had died because he had negligently not brought enough water with him for the voyage. The case went to maritime court in Jamaica, where the jury ruled in favor of the ship's owners and ordered the insurer to pay off the claim. The insurer then appealed, and the case was heard in England, reaching the British equivalent of the Supreme Court in 1783."



I do not know how Ghana could in good conscience pretend this did not happen or deny they owe African descents like myself and many others compensatory repair, for the parts played in our ancestor's sheer torment, and as a result, for the positions in which we now find ourselves today. None of which should go to money grabbing politicians in questionable island parliaments but to bloodlines who can prove ancestry connected to each Afrikan country. The above video clearly states who were involved, yet Jamaica is not guiding the people accordingly, or providing lawyers for the population to petition Ghana for payment directly to descents. I am not impressed with or by diplomatic games, when it can all be handled at the individual and personal level.

Neither is Barbados doing anything useful, and both islands carry a large population of Ghanaian descents, but they do not seem to care after making all kinds of arrangements above our heads without our consent. The money in individual island treasuries, contrary to politicians' popular belief, does not belong to them but to the people who generate it, and as such should be made immediately available to populations who are entitled to it, so they can access international lawyers, who can get to work forthwith.

If Nigeria, Ghana and other slavery countries of Afrika refuse to settle this matter diametrically with descents, and not with employee politicians who have absolutely no authority, there is available recourse. This is the only way, the right approach, and the reason why everyone is correctly seeing the actions of politicians on both continents as a "grift."

The Ashanti King should be ashamed of himself in trying to duck accountability, but only digging a deeper hole for Black Americans who are now beyond outraged to bury him in its legal depths. I see him along with those presidents from the AU, and the other kingdoms so deeply entangled by authentication of guilt, as being no different to, or any better than the repulsive owners of the Zong.



Even though American Afrikan descents showed genuine interest and the best of intentions toward Ghana/Afrika by generating billions in revenue for their scheme. There was absolutely no gratitude in return, Afrika never reciprocated, as U.S Blacks were still subjected to degrading insults to break their spirits, still verbally attacked by Afrikans in the US today as seen on videos.

For those unfamiliar with Afrikan dialects, the below words basically mean "slaves." They are projecting the millennia old slavehood maintained and directed at them to this day by their varying masters onto Black Americans. Instead of radically eradicating diabolical subversion, they decided to go after American cousins. Now the decades of artifice has completely fallen apart, and reduced a talking point everywhere. "Africans continue to profit from the trans-Atlantic slave trade shamelessly. Revenue is generated from memorials, museums, slave castles, and doors of no return. "Jewish victims of the holocaust would never go on a tour with the children of Nazis. Under the cloak of Pan-Africanism, using tourist traps ("Year of Return," etc.), Africans prey on the sentimentality and misplaced reverence held for the continent. Without guilt or embarrassment, the locals are willing to take advantage of the longing to connect with the "motherland," often resulting in Black Americans being scammed, robbed, kidnapped, or killed (e.g., Mame Lena Diop, 75, Nzinga Janna, 69, etc.). African nations should justly pay the revenue they've collected from slave-trade memorials and institutions to the impoverished Black Americans."

Intense caution must be exercised at all times, it is heartbreaking everything reached to this, an unnecessary juncture. There is a problem with leadership allowing the plague of hate to devour Afrikan minds with a psychosis. When information is available to quell such madness, lack of knowledge is no excuse.
